Registrant further agrees to release and hold harmless NRCHA, its employees, representatives, agents and anyone else working at the event who through negligence or carelessness otherwise might be liable in damages to registrant. This release and waiver of liability shall be binding on Registrants heirs, representatives, dependants, and successors in interest.
