Entry fees are due March 29, 2010. There will be a 25% penalty assessed for payments postmarked after the deadline. Entry fees for the Hackamore Classic are - \$1400 for the Open and Non Pro Divisions, \$650 for the Amateur Division. Those entering the Intermediate Open and/or Limited Open Division must pay \$450 per division and be entered in the Open Division. Those entering the Intermediate Non Pro Division must pay \$450 and be entered in the Non Pro Division. The Hackamore Classic is open to horses 5 years of age and under that have never been shown in a bridle down the fence at any judged reined cow horse event held anytime or any place. Horses must be shown in a hackamore as described in the general rules for equipment. The rider shall use closed reins. Two hands must be used on the reins, except in the herd work. The NRCHA Rule Book contains the rules for Limited Aged Events and the Hackamore Classic and will be followed as printed. Both owner and rider must be current 2010 NRCHA members. *Entries are not valid without payment in full.* NO CALL-IN ENTRIES, PLEASE. If you have any questions call the NRCHA office at 580-759-4949.

Waiver and Release of Liability:

By signing below, I hereby acknowledge that I meet the criteria for eligibility to compete in the classes entered according to the guidelines set forth in the NRCHA Rule Book. Registrant also acknowledges that riding and showing reined cow horses are inherently dangerous activities that expose the participant to a substantial risk of serious property damage, personal injury, or death. In consideration for the right to participate in such activities, or any other activity that the registrant may participate in at the NRCHA Hackamore Classic, registrant assumes the risk of injury or death of participating in those activities and hereby releases National Reined Cow Horse Association ("NRCHA") and its employees, representatives and all other agents associated with NRCHA from liability for any personal injury, property damage, or death that occurs from those activities. Registrant further agrees to release and hold harmless NRCHA, its employees, representatives, agents and anyone else working at the event who through negligence or carelessness otherwise might be liable in damages to registrant. This release and waiver of liability shall be binding on Registrants heirs, representatives, dependants, and successors in interest.

I have read and understand the terms and conditions of the entry into this event and agree to abide by those terms and conditions and the NRCHA Rule Book. I agree as a condition of in consideration of acceptance of entry the National Reined Cow Horse Association may use or assign photographs, videos, audios, cablecasts or other likeness of me and my horse taken during the course of competition for the promotion, coverage or benefit of the competition, sport or the NRCHA. Those likenesses shall not be used to advertise a product and they may not be used in such a way to jeopardize non pro/amateur status. I hereby expressly and irrevocably waive and release rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity or to misappropriation. I have the authority and hereby do, by making this entry, assume responsibility for and bind owner, rider and/or agent to the terms and conditions of this Release and Waiver of Liability.
