Entry fees are due December 30, 2011. There will be a 25% penalty assessed for payments postmarked after the deadline. Those entering the Intermediate Open and/or Limited Open Divisions must pay \$350 per division and be entered in the Open Division. Those entering the Level 1 Limited Open do NOT need to enter the Open Division; it is a standalone division and will have its own draw. If the horse is entered in this class and in the Open division, the horse will show in the Open Draw and the score from the Open will be counted in the Level 1 Limited Open; horses will not have to run twice unless riders are not the same. The Novice Horse class will run concurrent with the Open division, but those entering the Novice Horse class do not need to enter the Open Division. Non Pro entries are automatically entered into all Non Pro divisions for which they are eligible (Intermediate Non Pro and Novice Non Pro only). Those entering the Amateur Division do NOT need to be entered in the Non Pro Division. The Non Pro Limited division follows the same rules as the Horse Show Non Pro Limited eligibility (see Rule 10.4.12). The Circle Y Ranch Derby is open to horses 4 & 5-years-old shown in a hackamore or snaffle bit. Two hands must be used on the reins, except in the herd work. The NRCHA Rulebook contains the rules for Limited Aged Events and the Circle Y Ranch Derby and will be followed as printed. Both owner and rider must be current 2012 NRCHA members. Entries are not valid without payment in full. NO CALL IN ENTRIES PLEASE.

Waiver and Release of Liability:
By signing below, I hereby acknowledge that I meet the criteria for eligibility to compete in the classes entered according to the guidelines set forth in the NRCHA Rule Book. Registrant also acknowledges that riding and showing reined cow horses are inherently dangerous activities that expose the participant to a substantial risk of serious property damage, personal injury, or death. In consideration for the right to participate in such activities, or any other activity that the registrant may participate in at the Circle Y Ranch Derby, registrant assumes the risk of injury or death of participating in those activities and hereby releases National Reined Cow Horse Association ("NRCHA") and its employees, representatives and all other agents associated with NRCHA from liability for any personal injury, property damage, or death that occurs from those activities. Registrant further agrees to release and hold harmless NRCHA, its employees, representatives, agents and anyone else working at the event who through negligence or carelessness otherwise might be liable in damages to registrant. This release and waiver of liability shall be binding on Registrants heirs, representatives, dependants, and successors in interest. I have read and understand the terms and conditions of the entry into this event and agree to abide by those terms and conditions and the NRCHA Rule Book. I agree as a condition of acceptance of entry the National Reined Cow Horse Association may use or assign photographs, videos, audios, cablecasts or other likeness of me and my horse taken during the course of competition for the promotion, coverage or benefit of the competition, sport or the NRCHA. Those likenesses shall not be used to advertise a product and they may not be used in such a way to jeopardize Non Pro/Amateur status. I hereby expressly and irrevocably waive and release rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity or to misappropriation. I have the authority and hereby do, by making this entry, assume responsibility for and bind owner, rider and/or agent to the terms and conditions of this Release and Waiver of Liability. I warrant that I am of legal age, or am the parent or legal guardian of the participant named above, and that I have read and fully understand the foregoing terms.
