



# NRCHyA Costume Class Fundraiser "The Wild Bunch"

Held during the NRCHA Celebration of Champions



## RULES AND GUIDELINES:

1. NRCHA rules apply.
2. Class will be held Thursday, February 2, 2012 following the World's Greatest Horseman Rein Work Preliminaries.
3. **Limited Division:** (Boxing class) Non Pro or Youth riders that have not gone down the fence more than three times.
4. **Open Division:** (Fence class) All Open, Non Pro, or Youth riders.
5. **Rein Work:** Rider can make up their own pattern. Rider must include, but is not limited to, the following:
  - One (1) circle in each direction
  - Two (2) lead changes in each direction (one right to left, one left to right)
  - Three (3) stops
  - Two (2) spins in each direction
  - Rein Work is limited to 3 1/2 minutes
6. **Limited Cow Work:** Cow will be boxed for 50 seconds.
7. **Open Cow Work:** Time limit of 2 minutes and 30 seconds.
8. Any horse can be shown more than once, but with a different rider.
9. **Music:** Riders must have music during the run. Please bring a CD or iPod to the Media Office. It must be received by NOON on Wednesday, February 1. Music must be verified by NRCHA Staff. Please choose your song carefully, and remember to choose a song that is long enough for your run.
10. **Costume:** Riders MUST wear a costume. Must be within decency.
11. **Entry Fee:** \$50.00; 50% to Jackpot and 50% to donation for NRCHyA.
12. Winner in each division will be determined by high score. Payout will be determined by NRCHA payout schedule.
13. Best costume will receive special award.
14. Open to ALL AGES.

This release and waiver of liability shall be binding on Registrants heirs, representatives, dependants, and successors in interest.

I have read and understand the terms and conditions of the entry into this event and agree to abide by those terms and conditions and the NRCHA rulebook. I agree as a condition of in consideration of acceptance of entry the National Reined Cow Horse Association may use or assign photographs, videos, audios, cablecasts or other likeness of me and my horse taken during the course of competition for the promotion, coverage or benefit of the competition, sport or the NRCHA. Those likenesses shall not be used to advertise a product and they may not be used in such a way to jeopardize non pro/amateur status.
