- II. Approval of Minutes presented by Boyd Rice
 - a. February 9, 2023
 - i. Dr. Joe Carter moved to approved the minutes; Trey Neal seconded. MOTION PASSED, none opposed.
- III. Committee Reports
 - a. Executive Committee / Finance
 - i. There was no report from the Executive Committee / Finance.
 - b. Affiliate

- e. Hall of Fame

- i. Lance Johnston reports that there will be a Judges' Committee Meeting on Tuesday, March 28 following the show. Some topics to be covered are judge ethics, steer stopping, continued judge education, two-point penalty marker, adding more patterns, Box Drive judging.
- h. Non Pro
 - i. Diane Edwards reports that the Non Pro Committee would like to change the \$750 rule to go in affect at the end of the year, rather than throughout the year
 - ii. Edwards reports that the NP Committee has interest in changing the Select age from 55 to 50.
 - iii. Edwards reports that the NP Committee would like to try a Select Box Drive division at the Western Derby as a Cat 2 class.
 - iv. Edwards reports that the NP Committee would like to rename the World's Greatest Non Pro. Board discussion. Dan Roeser makes a motion to accept the name World's Greatest Non Pro. Corey Cushing seconded. MOTION PASSED, none opposed.
 - v. Edwards reports on the reports on the results from the NP survey that was emailed out. They received 997 surveys back. Non Pros are not in favor of sponsorships. 54% of Non Pros did not agree with lopers being paid and holding Non Pro Status.
 - vi. Edwards reports that there is a request from the NP Committee to get arena banners for NPs that have earned over 500K in earnings.

 - The board agrees that the affiliates can charge for memberships and asks for verbiage for the next meeting.
 - NRCHA 12.1.9 (McCleary)
 - Dan Roeser makes a motion to change from radius to miles driven. Todd Bergen seconded. MOTION PASSED, none opposed.
 - Scratch Entry Retainage (McCleary)
 - The board agrees to change the retainage from 20% to 30% and asks for verbiage for the next meeting.
 - Suspension of Kaleigh King (Konkel)
 - The board agrees to keep the suspension in place per the NRCHA rulebook.
 - Matthew Kimes refund request (Konkel)
 - Paul Bailey makes a motion that we charge the cattle fee only. Trey Neal seconded. MOTION PASSED, none opposed.
- I. Show
 - i. Incentives (Konkel/Crawford)
 - The board requests that Konkel/Crawford continue to develop the incentive idea.
 - ii. How to count money won from sanctioned events (Crawford)
 - Todd Crawford makes motion to change eligibility earnings from Category 2 events to count towards lifetime earnings only but NOT eligibility earnings. Jake Telford seconded. MOTION PASSED, none opposed.
 - iii. NRCHA Circuit Program (Konkel)
 - The board embraces the idea of the Circuit Program and asks staff to move forward.
 - iv. Future dates on Stallion Stakes (Konkel)
 - Konkel discusses the future dates of the NRCHA Stallion Stakes. Board agrees to move back 1 week in 2024, and 2 weeks in 2025 and 2026.
