



## 2024 Kimes Ranch Western Derby Trade Show

Thank you for your interest in attending the 2024 Kimes Ranch Western Derby in Scottsdale, Arizona, as a trade show vendor!

### **Dates & Hours:**

Move-in is tentatively set to begin on Monday, May 27, a move-in schedule will be provided closer to the move-in date. All vendors must be in place by 6 p.m. on May 28. Tear down may begin no earlier than the end of the Open Derby awards presentation at the end of the show on Saturday, June 8. Vendors should remain open during show hours, starting at 8 a.m. each day and not closing earlier than 6 p.m. on each day of the show.

### **Pricing:**

Below is the pricing information for the 2024 Trade Show. All vendor spaces will be assigned on a first-come, first-served basis after sponsors claim their space on April 21. We will begin notifying vendors who applied for space if they have space at the show by May 2, 2024.

### **Payment:**

Upon approval of vendor space, 50% of space payment will be required. The remaining balance must be paid to NRCHA upon the vendor's arrival at the facility. All checks can be made to NRCHA, and credit cards can be charged with an additional 3.5% fee.

### **About the Show:**

At the Kimes Ranch Western Derby, increased added money awaits the 4- and 5-year-old horse and rider pairs, many of which competed at the NRCHA Snaffle Bit Futurity® when the horses were 3 years old. Horses may be shown in either a snaffle bit or a hackamore in the Western Derby. They are judged in three challenging events: herd, work, rein work, and fence (cow) work, with a preliminary round of competition to determine who will return for the clean-slate finals. The Kimes Ranch Western Derby features divisions to suit all levels, from million-dollar riders in the Open, entry-level competitors in Level 1 and Non-Pro Boxing, and every level of competitor in between.
