In consideration for the right to participate in such activities, or any other activity that the registrant may participate in at the NRCHA Celebration of Champions, registrant assumes the risk of injury or death of participating in those activities and hereby releases National Reined Cow Horse Association ("NRCHA"), Stock Horse of Texas ("SHTX") and its employees, representatives and all other agents associated with NRCHA and SHTX from liability for any personal injury, property damage, or death that occurs from those activities. Registrant further agrees to release and hold harmless NRCHA, SHTX, its employees, representatives, agents and anyone else working at the event who through negligence or carelessness otherwise might be liable in damages to registrant. This release and waiver of liability shall be binding on Registrants heirs, representatives, dependents, and successors in interest. I have read and understand the terms and conditions of the entry into this event and agree to abide by those terms and conditions and the SHTX Rule Book. I agree as a condition of in consideration of acceptance of entry the National Reined Cow Horse Association and the Stock Horse of Texas may use or assign photographs, videos, audios, cablecasts or other likeness of me and my horse taken during the course of competition for the promotion, coverage or benefit of the competition, sport or the NRCHA and SHTX.
